- Current 3-year budget does deliver a balanced budget by March 2025.
   However, inflation is a significant risk factor
- The support staff restructure is the first step
- Next steps include
  - Increasing number of children on roll (NoR)
  - Reducing overhead costs
  - Better use of estate: This has been a long-term strategy slowed by the pandemic
  - Increasing income
  - Continuous review
- The German School held on Saturday is due to bring in £15K per year when fully operational
- Camden are supportive of the school as long as the school is committed to make the necessary changes

## Questions

How much has been included in budget for increased cost for utilities? 35% has been advised. The school is part of Kent County Council Laser contract.

What has been included for inflation in other areas? Camden is currently advising 2 – 3 % but this will be reviewed regularly and reporting to Staffing and Finance termly. This is an area of risk.

**How much will school block increase each year?** Camden have advised 2% which is reflected in the budget. The funding is based upon the NoR in October each year (Census). These figures have been predicted however are subject to variation and will be updated as necessary.

**So the budget only went into deficit at the end of 21-22?** Yes that is correct. It was forecast to be £170K deficit, however ended slightly better at £145K. The SBM confirmed that with this forecast action was taken swiftly with the Support Staff restructure.

There are no SMSA costs in the 22-23 budget. Were they part of the support staff restructure? The TA's were also SMSA's and held two separate contracts. As part of the restructuring the SMSA duties have been rolled into the TA contract therefore there are no direct SMSA costs from April 2022.

**Is the German School profitable?** It will be. Obviously due to the pandemic it has been slow to start however in 22-23 income will be £15K. All classrooms are used.

Will the school be able to hire out for parties? This is not possible at present as it is not possible to lock down areas of the school. To enable this would require capital outlay. It is also not clear whether parties would be profitable.

**Has the school paid the redundancy costs?** No these have been paid by Camden.

What is the funding per pupil? It is approx. £5k per pupil per year from Reception to Year 6. Nursery have a different funding formula.

	Will the school move to 1.5 form entry? No, it is planned that the school remain 2 form entry  The Chair thanked the SBM for his comprehensive report, clear explanations and hard work.
